I intend to participate in **Art in the Barn Exhibit & Sale on September 25 & 26, 2020**, Friday noon-7pm & Saturday 10am-5pm in the Weber Barn, Jackson, WI 53037.

☐ I agree to be present a good part of the time; when I'm not available, I will appoint someone to be responsible for watching and selling my things, and I'll let Susie Weber know who is responsible. ☐ Also, I will be responsible for my own sales, either by having my own credit card reader or handling cash and checks myself, or I will arrange for another exhibitor to handle my sales for me. Susie is willing to process sales when customers prefer to make only one transaction but purchase from multiple vendors.

☐ I understand that accidents can happen even when we all try to do whatever we can to prevent that. ☐ I agree to the following "Hold harmless" statement: *I will hold harmless Susie and Terry Weber and/or Art in the Barn from any and all claims, lawsuits, demands, causes of action, liability, loss, or damage of any kind (including without limitation all claims of monetary loss) resulting from my participation in Art in the Barn.*

☐ I will bring my exhibit items to the barn by September 22, and I'll let Susie know when I expect to come. I realize that **everything needs to be priced and in the barn by Thursday, September 24** so there's time for last-minute re-arranging and adding finishing touches such as fresh flowers so that everything is ready to go before noon Friday. ☐ I will pick up my remaining exhibit items **after the event Saturday, September 26 or within a few days of the event.**

☐ There will be no commission be charged on work I sell. But I do agree to share costs of the event—such as renting a Porta-Potty, signage, postcards and providing some refreshments for participants. ☐ The shared cost is **\$50 per exhibitor, payable by check or cash to Weber Design Inc., and it is due, along with this signed form, as soon as possible. That way we can start showcasing each artist on the website. I will refund this fee if we are cancelled due to the pandemic, or other unforeseen issues.**

☐ Susie is providing **25 promotional postcards** for each participant (if you will need extras just let Susie know). Please **email Susie a few photos of your work and a few sentences about you and your work** so that we can promote the event on our facebook page, possible ads/postings with targeted art communities and our new web site **www.art-in-the-barn.com!** (It'll be live soon!)
